### Important information for the prospective resident

### Notice for prospective residents

Before you decide whether to live in a retirement village, you should:

- Seek independent legal advice about the retirement village contract – there are different types of contracts and they can be complex
- Find out the financial commitments involved – in particular, you should understand and consider ingoing costs, ongoing fees and charges (which can increase) and how much it will cost you when you leave the village permanently
- Consider any impacts to any pensions, rate subsidies and rebates you currently receive
- Consider what questions to ask the village manager before signing a contract
- Consider whether retirement village living provides the lifestyle that is right for you. Moving into a retirement village is very different to moving into a new house. It involves buying into a village with communal facilities where usually some of the costs of this lifestyle are deferred until you leave the village. These deferred costs when you leave your unit may be significant.
- Seek further information and advice to help with making a decision that is right for you. Some useful contacts are listed at the end of this document, including:

### More information

- If you decide to move into a retirement village, the operator will provide you with a Prospective Costs Document for your selected unit, a residence contract and other legal documents.
- By law, you must have a copy of the Village Comparison Document, the Prospective Costs Document, the village by-laws, your residence contract and all attachments to your residence contract for at least 21 days before you and the operator enter into the residence contract. This is to give you time to read these documents carefully and seek professional advice about your legal and financial interests. You have the right to waive the 21-day period if you get legal advice from a Queensland lawyer about your contract.

### ***Development of retirement village***

The operator intends to develop the village in multiple stages:

1. Stage 1 (Building A) to include 69 accommodation units, a resident's lounge and master club, BBQ area, art studio, library and theatre.
2. Stage 2 (Building B) to include approximately 87 accommodation units, and a rooftop terrace.
3. Stage 3 (Building D) to include approximately 55 accommodation units and various facilities which may include, without limitation, an outdoor mixed-use recreational area, private dining room, bar and cafe, lobby, gym and exercise studio, day spa and consultation rooms, indoor swimming pool and village office.
4. Stage 4 (Building C) to include approximately 89 accommodation units.

Some or all of the above work will constitute 'redevelopment' for the purposes of section 113C of the *Retirement Villages Act 1999*.

Further information regarding development of the village is available on request. A proposed master plan for the retirement village is available for inspection on request. The master plan shows the accommodation units and facilities to be constructed.

Refer to the 'Access to documents' section of this Village Comparison Document for more details regarding documents relating to the development of the village which are available for inspection.

Construction of the retirement village is planned to commence in 2019 and is planned to be completed by 2024. The operator is not able to guarantee that construction of the retirement village will be commenced or completed by these dates.

The operator reserves the right at its discretion to:

- construct the village in stages;
- construct further accommodation units, including as part of future stages at the village;
- alter the type, size, configuration or design of the units;
- relocate, reconfigure, renovate, redevelop, extend and/or improve any facilities;
- subdivide or further subdivide a lot comprising the village land;
- surrender or partially surrender any head lease and enter into a head lease over a smaller area;
- construct additional rooms or areas in the retirement village to be used for the purpose of office, temporary accommodation or administration; and
- alter the size of the village, by incorporating additional or adjoining land into the village or disposing of, or removing, land forming part of the village.

**Note:** Aged care facilities are not covered by the *Retirement Villages Act 1999* (Qld). The retirement village operator cannot keep places free or guarantee places in aged care for residents of the retirement village. To enter a residential aged care facility, you must be assessed as eligible by an Aged Care Assessment Team (ACAT) in accordance with the *Aged Care Act 1997* (Cwth).

Exit fees may apply when you move from your retirement village unit to other accommodation and may involve entering a new contract.

'General Services' provided to all residents are:

- Operating the retirement village for the benefit and enjoyment of residents.
- Providing, operating and managing the community areas and facilities.
- Providing a village concierge.
- Managing security at the retirement village.
- Maintaining any emergency help system and/or safety equipment.
- Maintaining fire-fighting and protection equipment.
- Providing, operating and maintaining any lifts in the retirement village.
- Maintaining safety and emergency procedures for the retirement village.
- Cleaning, maintenance, repairs and replacements of and to the community areas and facilities.
- Maintenance, repairs and replacements to units and items in, on or attached to the units (except where this is a resident's responsibility).
- Pest control.
- Engaging staff and contractors for the operation of the retirement village, which may include a village manager, village concierge, cleaning, maintenance and security personnel and/or relief personnel.
- Arranging for administrative, book-keeping, accounting and legal services necessary for the operation of the retirement village.
- Maintaining any licences required in relation to the retirement village and otherwise complying with all applicable laws.
- Paying operating costs in connection with the ownership and operation of the retirement village.
- Maintaining insurances relating to the retirement village, whether required by legislation, contemplated by a residence contract or otherwise deemed appropriate by the scheme operator.
- Providing, operating and maintaining an embedded electricity network.
- Various other general services budgeted from time to time.

## Part 10 - Ongoing Costs - costs while living in the retirement village

**General Services Charge:** Residents pay this charge for the general services supplied or made available to residents in the village, which may include management and administration, gardening and general maintenance and other services or facilities for recreation and entertainment described at 7.1.

**Maintenance Reserve Fund contribution:** Residents pay this charge for maintaining and repairing (but not replacing) the village's capital items e.g. communal facilities, swimming pool. This fund may or may not cover maintaining or repairing items in your unit, depending on the terms of your residence contract.

The budgets for the General Services Charges Fund and the Maintenance Reserve Fund are set each financial year and these amounts can increase each year. The amount to be held in the Maintenance Reserve Fund is determined by the operator using a quantity surveyor's report.

**Note:** The following ongoing costs are all stated as weekly amounts to help you compare the costs of different villages. However, the billing period for these amounts may not be weekly.

**Notes from scheme operator:** The amounts in the table at part 10.1 above are the estimated amounts based on the general services budget and Maintenance Reserve Fund budget for the 2020/2021 financial year (being the projected first year of operation of the village) and may be subject to change.

The above General Services Charge amounts exclude the above Maintenance Reserve Fund contribution amounts listed.

The general services and Maintenance Reserve Fund budgets are prepared on the basis of 1 full year of operation. However, depending on the precise time for completion, the retirement village may operate for less than 1 full year of operation.

The scheme operator will subsidise the general services and Maintenance Reserve Fund budgets by paying the portion of General Services Charges and Maintenance Reserve Fund contributions that are payable in respect of any units that are not yet occupied. The subsidy will

be provided by the scheme operator until the relevant accommodation units are occupied by residents.

The General Services Charge and Maintenance Reserve Fund contributions will increase from time to time in the manner allowed under the Act.

The figures are based on the number of units anticipated to be constructed at the retirement village (i.e. 300 units).

The General Services Charge is calculated by dividing the initial annual contribution determined by the quantity surveyor by the number of units and then applying an adjustment factor depending upon the unit type. The Maintenance Reserve Fund contribution is calculated by dividing the initial annual contribution determined by the quantity surveyor by the number of units.

The General Services Charge and Maintenance Reserve Fund contributions are payable on a monthly basis, or such other period as notified by the scheme operator from time to time.
